CHAPTER 3.04

PURCHASES

<u>3.04.01</u> Authority of Mayor The Mayor or his duly authorized representative shall have the exclusive power and responsibility to make purchases of all supplies, apparatuses, equipment, materials, and other things required for public purposes in and for the city and to make all necessary contracts for work and labor to be done or material or other necessary things to be furnished for the benefit of the city, or in carrying out any work or undertaking of a public nature thereof. (Ord. No. 2010-619, Sec. 1.)

<u>3.04.02</u> \$20,000 or under The Mayor or his duly authorized representative shall not be required to invite competitive bidding for making purchases which do not exceed the sum of Twenty Thousand Dollars (\$20,000.00). (Ord. No. 2010-619, Sec. 2.)

<u>3.04.03</u> Competitive bidding Where the amount of expenditure for any purpose or contract exceeds the sum of Twenty Thousand Dollars (\$20,000.00), the Mayor or his duly authorized representative shall invite competitive bidding thereon by legal advertisement in any local newspaper.

A. Bids received pursuant to the advertisement shall be opened and read on the date set for receiving the bids in the presence of the Mayor or his duly authorized representative.

- B. The Mayor or his duly authorized representative shall have exclusive power to award the bid to the lowest responsible bidder, but may reject any and all bids received.
- C. The City Council, by ordinance, may waive the requirements of competitive bidding in exceptional situations where the procedure is deemed not favorable or practical. (Ord. No. 2010-619, Sec. 3.)

<u>3.08.01 Approval</u> Consolidation of the City PSAP is in the best interest of all City residents and is approved. (Ord. No. 21-855, Sec. 1)

<u>3.08.02 Positions</u> The city of Clarksville will maintain three positions on the 911 Advisory board consisting of one position provided by a delegate of the Clarksville City Council, the Clarksville Police Chief, and the Clarksville Fire Department. (Ord. No. 21-855, Sec. 2)

<u>3.08.03</u> Funding The City of Clarksville shall appropriate and provide 60% of the fixed costs between 911 tax-based revenues and actual expense of operating the PSAP.

Capital improvements funds of \$20,000.00 will be appropriated and provided by the City for capital improvements of the PSAP in a separate fund maintained by the Clarksville City Clerk. (Ord. No. 21-855, Secs. 3 & 4)

<u>3.08.04</u> Authority The Mayor shall be empowered and authorized to undertake such actions necessary to effectuate the provisions of this ordinance, including entering into agreement with Johnson County and other local political subdivisions in furtherance of consolidating and operating the PSAP (Ord. No. 21-855, Sec. 5)
